

Contacting your Government Officials

It is most important to contact your state representatives. These battery and high voltage wire projects are being driven by NY State. Items to mention:

- Support Home Rule and protest the ability of NYS to override local control and ordinances via the RAPID Act in order to fast track battery and transmission lines without local approvals. Gov. Hochul does not want the Federal Government telling her what to do, and we don't want her telling local government what to do.
- Halt the Construction of the Propel High Voltage Cables on our Residential Streets and waterways.
- Halt the construction of dangerous BESS facilities (Battery Energy Storage Systems) in residential areas.

These transmission lines and battery storage facilities are only necessary because of the off-shore windmills. They technically separate projects, but clearly interconnected.

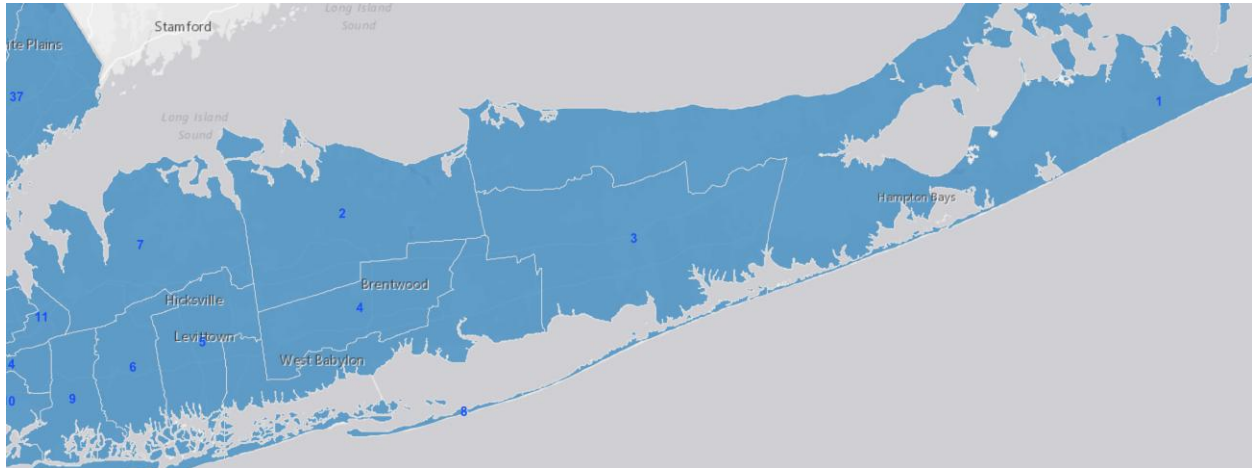
After contacting state officials, work on Town and County officials asking them to push back against the States efforts to circumvent home rule and push back on the siting of these dangerous facilities.

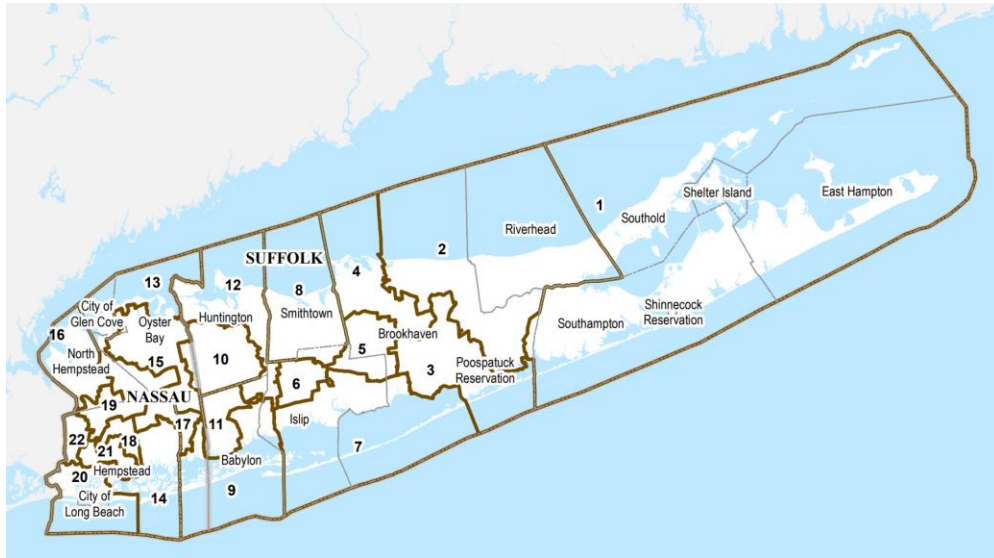
